### 11.00 – 12.45 **Breakout session 1:** Ports as regional development hubs

Parallel sessions

Ports are the gateway to the blue economy, with many industries such as aquaculture, tourism and Marine Renewable Energy relying on their infrastructure. Having to manage a wide range of stakeholders, ports can use this to act as key actors in the development of a region. Especially smaller Atlantic ports can play a key role, focusing beyond traditional logistical issues.

Breakout session 2: Increasing the attractiveness of blue economy jobs

Most students still do not choose to follow a career in the blue economy. This is in part due to the lack of information available on the possibilities as well as the fact that there still

exists a skills gap between the needs of the industry and the offers of educational institutions. The Atlantic area is home to many innovative blue industries such as Marine Renewable Energy and would benefit from a joint effort of mobilisation.

# Parallel sessions

The seabed of the Atlantic still remains largely unexplored, while it hosts deep-sea resources that that bear huge potential for innovation. Atlantic ports can, due to their smaller size and diversity, play a key role in facilitating marine exploration by providing the necessary infrastructure for the construction and deployment of specialized naval vehicles. Collaboration and cooperation could lead to Atlantic ports becoming pioneers in scientific infrastructure and key partners of research institutions.
